

## INTERNET ADVERTISING AGREEMENT

The undersigned Advertiser agrees with the Aquila Legis Fraternity 2016 International Convention Committee (The Committee) to advertise in the Aquila Legis Fraternity 2016 International Convention Website (Convention Website) located at [www.aquilalegis.org](http://www.aquilalegis.org) subject to the following terms.

1. Types of Advertisement. Advertiser must choose between Button Advertisement and Banner Advertisement.
2. Basic Listing. The Committee shall publish in the Contributor's Page of the Convention Website a Basic Listing containing Advertiser's digital logo or image, if any, business name and address, contact name, telephone/fax numbers and E-mail address along with a link to either the Button Advertisement or Banner Advertisement as chosen herein by the Advertiser.
3. Button Advertisement. If Button Advertisement is chosen, The Committee shall publish the Advertiser's advertisement on an 11" x 8" Ad Page in the Convention Website. For the creation of Advertiser's Ad Page, Advertiser shall provide to The Committee its ad content, substance of which is compatible to the Convention Website, and in digital format, e.g. Word, or digital photo delivered as e-mail attachment to [2016IntlConvCom@aquilalegis.org](mailto:2016IntlConvCom@aquilalegis.org).
4. Banner Advertisement. If Banner Advertisement is chosen, The Committee shall publish Advertiser's Website in the Convention Website. For this purpose, Advertiser shall provide to The Committee the link to Advertiser's Website by e-mail to [2016IntlConvCom@aquilalegis.org](mailto:2016IntlConvCom@aquilalegis.org).
5. Changes to Ad Content. Advertiser shall have 3 days after notice that its advertisement has gone live to request in writing any change to the advertisement to correct error or omission in the Convention Website, otherwise the advertisement shall be deemed approved and the ad will remain in effect until the contract terminates. Request for changes to the ad content not arising out of error in the Convention Website will require execution of a new contract.
6. Advertising Fee. By affixing Advertiser's initials below next to the advertisement chosen, Advertiser chooses one of the advertisements and hereby agrees to pay to the Convention Committee the corresponding advertising fee.

7. Payment. A down payment equivalent to fifty percent (50%) of the advertising fee is due and payable upon the signing of this agreement, and the balance payment equivalent to the remaining fifty percent (50%) shall be due and payable on the date that the advertisement becomes live on the Convention Website. Payment shall be made on-line at [www.aquilalegis.org](http://www.aquilalegis.org) as follows:
  - a. Click "Advertise" tab in the Menu Header of the Home Page.
  - b. Click to make Down Payment to choice made of either Button or Banner Advertisement.
  - c. Click to make Balance Payment to choice made of either Button or Banner Advertisement.
8. Term. The term of advertising shall commence on the first date that the advertisement goes live on the Convention Website and terminate at the end of one year.
